## INTRODUCTION

On behalf of the Board of Directors of IGB and KrisAssets, CIMB Investment Bank Berhad ("CIMB") and Hong Leong Investment Bank Berhad ("HLIB") wish to announce that IGB proposes to establish and list a real estate investment trust ("IGB REIT") on the Main Market of Bursa Securities. The initial investment portfolio of IGB REIT shall comprise a 8-storey retail mall known as The Gardens Mall and a 5-storey retail mall with 1 mezzanine floor known as Mid Valley Megamall ("Subject Properties"), which are currently owned by the whollyowned subsidiaries of KrisAssets, which in turn is a subsidiary of IGB. KrisAssets, via its subsidiaries, proposes to dispose the Subject Properties to IGB REIT ("Proposed Disposal").

## APPOINTMENT OF ADVISERS

CIMB, Credit Suisse (Singapore) Limited and HLIB have been appointed as the Joint Global Co-ordinators and Joint Bookrunners for the proposed initial public offering and listing of IGB REIT on the Main Market of Bursa Securities.

CIMB and HLIB have also been appointed as the Joint Principal Advisers for the Proposed REIT Establishment and Listing and the Proposed Disposal.

## SUBMISSION OF APPLICATIONS

CIMB and HLIB, have on behalf of IGB REIT Management, submitted an application to the Securities Commission ("SC") today for its approval of the valuation of the Subject Properties in conjunction with the Proposed REIT Establishment and Listing ("Valuation Application"). CIMB and HLIB, have also on behalf of KrisAssets submitted an application to Bursa Securities today for its approval on the valuation of the Subject Properties in conjunction with the Proposed Disposal.

A separate application for the Proposed REIT Establishment and Listing will be submitted to the SC within 1 month from the Valuation Application, as required under the SC's Guidelines on Real Estate Investment Trusts and the Capital Markets and Services Act, 2007.
